Our integrated health service provides Occupational Therapy to clients of all ages through the following programs/ streams: Acute ward, Subacute ward (GEM, rehabilitation, transition care), Outpatients, Community Rehabilitation Centre (CRC), Hospital Admission Risk Program (HARP), Community Health, Home and Community Care Program for Younger People (HACC PYP), Commonwealth Home Support Program (CHSP), Home Care Packages (HCP and Residential Aged Care.

This role is for a Grade 1 or Grade 2 depending on experience. Final year Occupational Therapy students are encouraged to apply.
