This position will see you working with a supportive and highly skilled team of pharmacists and pharmacy support staff to ensure optimal medication safety and service efficiency, whilst participating in innovative models of care and integrated approaches to medication safety and antimicrobial stewardship across sector services and in partnership with neighbouring hospitals and community partners. Training and education will be provided through formal and informal learning opportunities.

#### Primary responsibilities of this role include:

- Opportunity to have an academic role in the Mallee Clinical School.
- Undertake routine professional pharmacy tasks (including; taking a medication history upon admission, inpatient chart review, medication management planning, medication discharge planning, provision of discharge medication record, dispensing and counselling, liaison with community providers, medication safety improvement initiatives, periodic audits of prescribing, supply and controlled drug records, and other agreed key performance indicators) within established protocols.
