#### About the role:

Jacaranda Lodge is located around 27km north of Swan Hill in a rural setting and provides low and high care as well as respite. Families will find the rural setting ensures a tranquil, home-like environment with beautiful gardens.

The facility has a total of 30 beds, made up of 21 single rooms with ensuites, 3 single rooms with shared ensuites and 3 shared double rooms with shared ensuites. There is a communal dining area for residents with a kitchenette, a large community lounge area and 3 smaller lounge areas, laundry facilities and a chapel, all of which are available for you and your family.

The purpose of the role is to provide direct consumer care such as medication, wound management etc. and clinical supervision and advice to Nursing and other care staff on consumer care issues, and participate in clinical care of consumers as required.
