Swan Hill District Health is a 143 bed (including aged care) facility which employs approximately 750 professionals delivering unparalleled care to an estimated population of 40,000 within a 100 km radius on the banks of the might Murray River and about 3.5 hours from Melbourne. Over 12 months ago, we opened the doors to our new Emergency Department which currently sees about 16000 presentations per annum.
